Articles of Incorporation**

(Chapter 7-6-34 of the General Laws of Rhode Island, 1956, as amended)

ARTICLE I

The name of the corporation is Rescue Lounge, Inc.

ARTICLE II

The period of its duration is Perpetual

ARTICLE III

The specific purpose or purposes for which the corporation is organized are:

OFFERING LOCAL SHELTER DOGS A PORTABLE, LOUNGE-LIKE SPACE TO
SOCIALIZE, TRAIN, AND GET ADOPTED; THEREBY DECREASING THE NUMBER OF
STRAY
DOGS AND RETURNS.

THIS ORGANIZATION IS ORGANIZED EXCLUSIVELY FOR CHARITABLE,
EDUCATIONAL,
RELIGIOUS AND/OR SCIENTIFIC PURPOSES UNDER SECTION 501(C)(3) OF THE
INTERNAL REVENUE CODE, OR CORRESPONDING SECTION OF ANY FUTURE
FEDERAL TAX
CODE, AND SHALL NOT INURE BENEFIT OR EARNINGS TO ANY PRIVATE
SHAREHOLDER OR
INDIVIDUAL.

ARTICLE IV

Provisions, if any, not inconsistent with the law, which the incorporators elect to set forth in these articles of incorporation for the regulation of the internal affairs of the corporation are:

DISSOLUTION CLAUSE:
UPON THE WINDING UP AND DISSOLUTION OF THIS ORGANIZATION, AFTER
PAYING OR
ADEQUATELY PROVIDING FOR THE DEBTS AND OBLIGATIONS OF THE
ORGANIZATION, THE
REMAINING ASSETS SHALL BE DISTRIBUTED TO A NONPROFIT FUND.

FOUNDATION OR CORPORATION WHICH IS ORGANIZED AND OPERATED EXCLUSIVELY FOR ONE OR MORE EXEMPT PURPOSES WITHIN THE MEANING OF SECTION 501(C)(3) OF THE INTERNAL REVENUE CODE, OR CORRESPONDING SECTION OF ANY FUTURE FEDERAL TAX CODE, INCLUDING TO ANOTHER TAX-EXEMPT ORGANIZATION UNDER SECTION 501(C)(3), OR SHALL BE DISTRIBUTED TO THE FEDERAL GOVERNMENT, OR TO A STATE OR LOCAL GOVERNMENT, FOR A PUBLIC PURPOSE.
