Articles of Amendment

(Section 7-6-40 of the General Laws of Rhode Island, 1956, as amended)

ARTICLE I

The name of the corporation is Source Hub

If the entity's name is changing, state the new name: Source Hub

ARTICLE II

SOURCE HUB AIDS THE IMMIGRANT COMMUNITY IN ACCESSING BASIC NEEDS SERVICES, WHILE EDUCATING THEM ABOUT THEIR RIGHTS AND AVAILABLE RESOURCES. IT CONSISTS OF INNOVATED CONCEPTS TO REACH THE UNDERSERVED IMMIGRANT POPULATION WITH A FOCUS ON REACHING SURVIVORS OF SEXUAL ASSAULT AND DOMESTIC VIOLENCE. SOURCE HUB AIMS TO CLARIFY DAY TO DAY INFORMATION, BREAK DOWN BARRIERS TO SERVICES SUCH AS: MISINFORMATION, FEAR, LANGUAGE, LITERACY CHALLENGES, IMMIGRATION STATUS, AND STIGMAS.

DISTRIBUTION UPON DISSOLUTION. UPON TERMINATION OR DISSOLUTION OF THE SOURCE HUB, ANY ASSETS LAWFULLY AVAILABLE FOR DISTRIBUTION SHALL BE DISTRIBUTED TO ONE (1) OR MORE QUALIFYING ORGANIZATIONS DESCRIBED IN SECTION 501(C)(3) OF THE 1986 INTERNAL REVENUE CODE (OR DESCRIBED IN ANY CORRESPONDING PROVISION OF ANY SUCCESSOR STATUTE) WHICH ORGANIZATION OR ORGANIZATIONS HAVE A CHARITABLE PURPOSE WHICH, AT LEAST GENERALLY, INCLUDES A PURPOSE SIMILAR TO THE TERMINATING OR DISSOLVING CORPORATION.

THE ORGANIZATION TO RECEIVE THE ASSETS OF THE SOURCE HUB HEREUNDER SHALL BE SELECTED IN THE DISCRETION OF A MAJORITY OF THE MANAGING BODY OF THE CORPORATION, AND IF ITS MEMBERS CANNOT SO AGREE, THEN THE RECIPIENT ORGANIZATION SHALL BE SELECTED PURSUANT TO A VERIFIED PETITION IN EQUITY FILED IN A COURT OF PROPER JURISDICTION AGAINST THE SOURCE HUB, BY ONE (1) OR MORE OF ITS MANAGING BODY WHICH VERIFIED PETITION SHALL CONTAIN SUCH STATEMENTS AS REASONABLY INDICATE THE APPLICABILITY OF THIS SECTION. THE COURT UPON A FINDING THAT THIS SECTION IS APPLICABLE SHALL SELECT THE QUALIFYING ORGANIZATION OR ORGANIZATIONS TO RECEIVE THE ASSETS TO BE DISTRIBUTED, GIVING PREFERENCE IF PRACTICABLE TO ORGANIZATIONS LOCATED WITHIN THE STATE OF SOURCE HUB.

IN THE EVENT THAT THE COURT SHALL FIND THAT THIS SECTION IS APPLICABLE BUT

THAT THERE IS NO QUALIFYING ORGANIZATION KNOWN TO IT WHICH HAS A CHARITABLE PURPOSE, WHICH, AT LEAST GENERALLY, INCLUDES A PURPOSE SIMILAR TO THE SOURCE HUB, THEN THE COURT SHALL DIRECT THE DISTRIBUTION OF ITS ASSETS LAWFULLY AVAILABLE FOR DISTRIBUTION TO THE TREASURER OF THE STATE OF RHODE ISLAND TO BE ADDED TO THE GENERAL FUND.

ARTICLE III

The Amendment was adopted in the following manner:
