Articles of Incorporation**

(Chapter 7-6-34 of the General Laws of Rhode Island, 1956, as amended)

ARTICLE I

The name of the corporation is GHOST VENDOR OPERATORS ORG. Corp.

ARTICLE II

The period of its duration is Perpetual

ARTICLE III

The specific purpose or purposes for which the corporation is organized are:

THE CORPORATION IS ORGANIZED EXCLUSIVELY FOR CHARITABLE,
EDUCATIONAL,
RELIGIOUS, OR SCIENTIFIC PURPOSES WITHIN THE MEANING OF SECTION
501(C)(3) OF

CORPORATION EXCLUSIVELY FOR THE PURPOSE OF THE CORPORATION IN SUCH
MANNER, OR
THE SUCH ORGANIZATION OR ORGANIZATIONS ORGANIZED AND THE TIME
QUALIFY AS AN
EXEMPT ORGANIZATION OR ORGANIZATIONS UND SECTION 501 (C)(3) OF THE
INTERNAL
REVENUE CODE OF 1986, OR THE CORRESPONDING PROVISION OF ANY FUTURE
UNITED
STATES INTERNAL REVENUE LAW, AS THE BOARD OF DIRECTORS SHALL

DETERMINE.

ANY SUCH ASSETS NOT SO DISPOSED OF SHALL BE DISPOSED OF BY THE CIRCUIT COURT OF THE COUNTY IN WHICH THE PRINCIPAL OFFICE OF THE CORPORATION IS THEN LOCATED, EXCLUSIVELY FOR SUCH PURPOSES OR TO SUCH ORGANIZATION OR ORGANIZATIONS, AS SAID COURT SHALL DETERMINE, WHICH ARE ORGANIZED AND OPERATED EXCLUSIVELY FOR SUCH PURPOSES.
