**ARTICLE I**

THIS CORPORATION IS ORGANIZED EXCLUSIVELY FOR CHARITABLE NONPROFIT PURPOSES, WITH A SPECIFIC EMPHASIS AS IT PERTAINS TO FUNDRAISING TO FURTHER THE DEVELOPMENT AND MISSION OF, AND TO ASSIST THE VETERANS OF FOREIGN WARS POST #449, AND OTHER NONPROFIT ORGANIZATIONS THAT EXIST IN, AND AROUND THE STATE OF RHODE ISLAND. AND FOR ANY AND ALL OTHER PURPOSES FOR WHICH SIMILAR CORPORATIONS ARE ORGANIZED. NO PART OF THE ORGANIZATIONS INCOME, WITH THE EXCEPTION OF REIMBURSABLE EXPENSES IS DISTRIBUTED TO ITS MEMBERS, DIRECTORS OR OFFICERS.
