Articles of Incorporation**

(Chapter 7-6-34 of the General Laws of Rhode Island, 1956, as amended)

ARTICLE I

The name of the corporation is Beta Pi Rho Chi Chapter

ARTICLE II

The period of its duration is Perpetual

ARTICLE III

The specific purpose or purposes for which the corporation is organized are:

THE ORGANIZATION IS ORGANIZED EXCLUSIVELY FOR CHARITABLE, RELIGIOUS, EDUCATIONAL, AND SCIENTIFIC PURPOSES UNDER SECTION 501(C)(3) OF THE INTERNAL REVENUE CODE, OR CORRESPONDING SECTION OF ANY FUTURE FEDERAL TAX CODE. THE PURPOSES OF THE CORPORATION SHALL INCLUDE, MORE SPECIFICALLY, TO ENCOURAGE AND RECOGNIZE ACADEMIC AND INTELLECTUAL ACHIEVEMENT IN THE SCIENCE OF PHARMACY; TO ACHIEVE UNIVERSAL RECOGNITION OF ITS MEMBERS AS LIFELONG INTELLECTUAL LEADERS IN PHARMACY; TO INSTILL THE DESIRE TO PURSUE INTELLECTUAL EXCELLENCE AND CRITICAL INQUIRY TO ADVANCE THE SCIENCE OF PHARMACY; TO STIMULATE CRITICAL INQUIRY IN THE SCIENCE OF PHARMACY; TO CONTRIBUTE TO THE DEVELOPMENT OF INTELLECTUAL LEADERS; TO PROMOTE THE HIGHEST ETHICAL STANDARDS; AND TO FOSTER COLLABORATION TO ADVANCE THE SCIENCE OF PHARMACY; TO PROVIDE SCHOLARSHIPS AND AWARDS TO ENCOURAGE EDUCATION AND ACHIEVEMENTS THAT ADVANCE THE SCIENCE OF PHARMACY; AND ANYTHING REASONABLY RELATED TO THE FOREGOING.
