(Chapter 7-6-34 of the General Laws of Rhode Island, 1956, as amended)

ARTICLE I

The name of the corporation is GONGOLIER ROBOTICS EMPOWERMENT GROUP

ARTICLE II

The period of its duration is Perpetual _____

ARTICLE III

The specific purpose or purposes for which the corporation is organized are:

THE CORPORATION SHALL BE OPERATED EXCLUSIVELY FOR CHARITABLE PURPOSES WITHIN THE MEANING OF SECTION 501(C)(3) OF THE INTERNAL REVENUE CODE OF 1986, AS NOW IN EFFECT OR AS MAY HEREAFTER BE AMENDED.

MORE SPECIFICALLY, THE GONGOLIER ROBOTICS EMPOWERMENT GROUP (THE GROUP) IS ORGANIZED TO PROVIDE A FUNDING VEHICLE AND NETWORKING OPPORTUNITY FOR FIRST ROBOTICS COMPETITION TEAM 5112 THE GONGOLIERS (THE TEAM), IN ADDITION TO ANY SUBSIDIARY TEAM, STARTUP ROBOTICS PROGRAM, EDUCATIONAL OUTREACH PROGRAM, EDUCATIONAL OPPORTUNITY, OR ANY AND ALL INITIATIVES OR ENDEAVORS PURSUED BY THE TEAM THAT THE GROUP DEEMS TO BE OF BENEFIT TO THE OVERALL EDUCATIONAL EXPERIENCE OR MISSION OF THE TEAM.
