Articles of Amendment

UPON THE DISSOLUTION OF THE CORPORATION, ASSETS SHALL BE DISTRIBUTED TO ONE OR MORE NON PROFIT ORGANIZATIONS WITH EXEMPT PURPOSES WITHIN THE THE MEANING OF SECTION 501(C)3 OF THE INTERNAL REVENUE CODE OR SHALL BE GIVEN TO A LOCAL GOVERNMENT OF THE STATE WHERE IN THE PRINCIPAL OFFICE IS LOCATED FOR PUBLIC USE.
