## ARTICLES OF ORGANIZATION FOR BEV VOYAGE LLC

THIS ARTICLES OF ORGANIZATION ARE MADE AND ENTERED INTO ON 04/10/2023 BY AND BETWEEN GINA TORRICELLI AND PATRICK STEPIEN, FOR THE PURPOSE OF FORMING A LIMITED LIABILITY COMPANY UNDER THE LAWS OF THE STATE OF RHODE ISLAND.

### ARTICLE 1. NAME:

THE NAME OF THE LLC SHALL BE BEV VOYAGE.

### ARTICLE 2. PURPOSE:

THE PURPOSE OF THE COMPANY SHALL BE TO ENGAGE IN THE BUSINESS OF PROVIDING BARTENDING SERVICES FOR VARIOUS EVENTS, INCLUDING BUT NOT LIMITED TO, WEDDINGS, CORPORATE EVENTS, AND PRIVATE PARTIES.

### ARTICLE 3. PRINCIPAL PLACE OF BUSINESS

THE PRINCIPAL PLACE OF BUSINESS OF THE COMPANY SHALL BE LOCATED AT 77 RUTH AVE, RUMFORD, RI, 02916. THE COMPANY MAY ALSO ESTABLISH ADDITIONAL PLACES OF BUSINESS AS DEEMED NECESSARY OR CONVENIENT BY THE MEMBERS.

### ARTICLE 4. TERM

THE COMPANY SHALL HAVE PERPETUAL EXISTENCE, UNLESS EARLIER DISSOLVED IN ACCORDANCE WITH ITS OPERATING AGREEMENT OR BY LAW.

### ARTICLE 5. MEMBERS

THE COMPANY SHALL HAVE TWO MEMBERS, THE ORGANIZERS, WHO SHALL OWN THE COMPANY IN THE FOLLOWING PERCENTAGES:

A. GINA TORRICELLI: 50%

B. PATRICK STEPIEN: 50%

### ARTICLE 6. MANAGEMENT

THE MANAGEMENT OF THE COMPANY SHALL BE VESTED IN THE MEMBERS, WHO SHALL HAVE EQUAL VOTING RIGHTS ON ALL MATTERS. THE ORGANIZERS MAY APPOINT OFFICERS AND OTHER EMPLOYEES AS DEEMED NECESSARY OR CONVENIENT BY THE MEMBERS.

### ARTICLE 7. CAPITAL CONTRIBUTIONS

THE INITIAL CAPITAL CONTRIBUTIONS OF THE MEMBERS SHALL BE AS FOLLOWS:

A. GINA TORRICELLI: \$5,000

B. PATRICK STEPIEN: \$5,000

ARTICLE 8. DISTRIBUTION OF PROFITS AND LOSSES

THE PROFITS AND LOSSES OF THE COMPANY SHALL BE ALLOCATED TO THE MEMBERS IN PROPORTION TO THEIR OWNERSHIP PERCENTAGES AS SET FORTH IN ARTICLE 5.

ARTICLE 9. INDEMNIFICATION

TO THE FULLEST EXTENT PERMITTED BY LAW, THE COMPANY SHALL INDEMNIFY ITS MEMBERS AND OFFICERS FROM ANY AND ALL LIABILITY AND EXPENSES INCURRED IN CONNECTION WITH THEIR ACTIVITIES ON BEHALF OF THE COMPANY.

ARTICLE 10. DISSOLUTION

THE COMPANY MAY BE DISSOLVED BY A VOTE OF THE MEMBERS IN ACCORDANCE WITH ITS OPERATING AGREEMENT OR BY LAW.

ARTICLE 11. GOVERNING LAW

THESE ARTICLES SHALL BE GOVERNED BY AND CONSTRUED IN ACCORDANCE WITH THE LAWS OF THE STATE OF RHODE ISLAND.
