### **Specialty Solutions**

The specialty solutions segment manufactures (i) rotary vane and other types of pumps primarily for the commercial beverage and print industries; (ii) display merchandisers for the bakery, deli, food service, supermarket and convenience store industries; and (iii) hydraulic cylinders for truck manufacturers for the dump trailer, dump body, waste hauling and aviation services industries.

### **Scientific**

The Scientific segment manufactures refrigerators and freezers for scientific/medical storage needs.

### **Engraving**

The engraving segment applies functional and aesthetic textures to tools, for use in automotive plastics and a number of other industries. It also performs various tool finishing services and produces specialty molds that enable the production of "soft-skin" surfaces for automobiles. The Engraving Group also assists customers in customizing selection of desired textures and in the provision of various tool finishing and repair services.

### **Engineering Technologies**

The Engineering Technologies segment produces engineered parts in all workable metal alloys primarily using spin forming, stretch forming, heat treating, CNC and EDM machining, high speed milling and other fabrication services for aerospace, industrial, medical, commercial, military aviation, space, marine, defense, energy, oil and gas and nuclear applications.

### **Electronics**

The electronic products segment manufactures electronic assemblies, reed switches, electrical connectors, flow, pressure, proximity conductive and inductive sensors, toroids, reed relays, fixed and variable inductors, fluid level sensors, tunable inductors, transformers, and magnetic components, for application in a wide variety of commercial and defense industries.




