TO VACATE THE FORFEITURE OR REVOCATION OF THE CHARTER OF
FEATHERBED ESTATES HOMEOWNERS ASSOCIATION, INC

It is enacted by the General Assembly as follows.

1 SECTION 1. The time within which FEATHERBED ESTATES HOMEOWNERS
2 ASSOCIATION, INC. incorporated on October 24, 1984, shall file the reports for the years 1992,
3 1993, 1994, 1995, 1996, 1997, 1998, 1999, 2000, 2001, 2002, 2003, 2004, 2005, 2006, 2007, 2008,
4 2009, 2010, 2011, 2012, 2013, 2014, 2015, 2016, 2017, 2018, 2019, 2020, 2021, 2022, and 2023 as
5 required under the provisions of Chapter 6 of Title 7 of the General Laws, 1956, is hereby extended
6 to the 31st day of December, A D , 2023, if said corporation shall file in the office of the secretary
7 of state before December 31, 2023, the reports which it should have filed in the said years and shall
8 pay to the secretary of state the filing fees therefor, having previously thereto paid to the general
9 treasurer for the use of the state such sum as the attorney general shall decide should be paid by
10 said corporation as a compromise for the penalty or penalties for its failure to file such reports then
11 the forfeiture or revocation of the charter of said corporation shall thereupon, to wit, upon the filing
12 of said reports and the payment of said fees, be vacated and said corporation shall thereupon be
13 entitled to all of the privileges, benefits and powers and subject to the same duties and liabilities as
14 though no forfeiture or revocation of its said charter had taken place
15 SECTION 2. This act shall take effect upon passage
