(i) Except for those actions excluded by the provisions of the Rhode Island Business Corporation Act, any action required or permitted to be taken at a meeting of stockholders may be taken without a meeting upon the written consent of less than all the stockholders entitled to vote thereon if the stockholders who so consent would be entitled to cast at least the minimum number of votes which would be required to take such action at a meeting at which all stockholders entitled to vote thereon were present. In the event of such written action, prompt notice of such action shall be given to all stockholders who would have been entitled to vote upon the action if such meeting were held.

(ii) The stock of the corporation is subject to transfer restrictions as set forth in the bylaws of the corporation and certificates of stock of the corporation shall not be transferred or sold unless there is compliance with the provisions of such restrictions.
