(Chapter 7-6-34 of the General Laws of Rhode Island, 1956, as amended)

ARTICLE I

The name of the corporation is Warwick Light

ARTICLE II

The period of its duration is Perpetual

ARTICLE III

The specific purpose or purposes for which the corporation is organized are:

TO START, WE INTEND TO PRESERVE THE HISTORY OF WARWICK LIGHT LIGHTHOUSE, ALSO TO PROVIDE SERVICES TO THE COMMUNITY, MOST IMPORTANTLY THE SERVICE MEN AND WOMEN OF OUR COUNTRY. THIS INCLUDES ALL UNIFORMS INCLUDING EMT, FIRE, POLICE, MILITARY, AS WELL AS THOSE ELECTED INTO OFFICE SERVING OUR CITIES AND TOWNS.
