FOR
CHARITABLE PURPOSES WITHIN THE MEANING OF SECTION 501(C)(3) OF THE
INTERNAL
REVENUE CODE OF 1986, AS NOW ENACTED OR HEREAFTER AMENDED,
INCLUDING, FOR
SUCH PURPOSES, THE MAKING OF DISTRIBUTIONS TO ORGANIZATIONS THAT
ALSO
QUALIFY AS SECTION 501(C)(3) EXEMPT ORGANIZATIONS OF THE INTERNAL
REVENUE
CODE OF 1986, AS NOW ENACTED OR HEREAFTER AMENDED. ALL FUNDS,
WHETHER
INCOME OR PRINCIPAL, AND WHETHER ACQUIRED BY GIFT OR CONTRIBUTION OR
OTHERWISE, SHALL BE DEVOTED TO SAID PURPOSE.
