

Annual Report 2023

The Board of Directors voted to dissolve Above the Line RI in May 2023.

The first goal since establishing our 501(3)(c) status in September 2022 was to raise funds to purchase a multi-family property in a RI town or city to begin our affordable rental program one day.

We have received a total of \$463.79 in donations while in operation after deducting the \$35 registration fee to participate in the 401Gives fund-raising event that occurred during the month of April 2023.

As outlined in our bylaws, upon dissolution 100% of this money received has been donated to SWAP (Stop Wasting Abandoned Property) of RI on May 17, 2023. The donation was sent by certified mail. We received a confirmation thank you letter dated June 12, 2023 from SWAP with a copy of the money order attached.

All Above the Line start-up fees and monthly maintenance of a phone line were funded by Darlene Gormly, Founder, and there are no outstanding operational liabilities or payments due to any entities by Above the Line RI.

Email notices were sent to each individual donor, along with a final announcement/newsletter of the dissolution of Above the Line RI in May 2023.
