

Articles of Incorporation

Section Four:

No part of the net earnings shall inure to the benefit of private shareholders, individuals or members. Upon dissolution of the corporation, the board of directors, after paying or making provision for the payment of all of the liabilities of the corporation, shall dispose of all assets exclusively for the exempt purposes of the corporation within the meaning of Section 501 (c) (7), of the Internal Revenue Code or shall distribute them to an organization organized and operated exclusively for charitable purposes which shall at that time qualify for exemption under Section 501 (c) (7) of the Internal Revenue Code or corresponding section of any future tax code.
