Articles of Incorporation**

(Chapter 7-6-34 of the General Laws of Rhode Island, 1956, as amended)

ARTICLE I

The name of the corporation is Lighthouse Skateboarding Corp.

ARTICLE II

The period of its duration is X Perpetual

The specific purpose or purposes for which the corporation is organized are:

SECTION 501 (C)
(3) OF THE INTERNAL REVENUE CODE, OR CORRESPONDING SECTION OF ANY
FUTURE FEDERAL
TAX CODE. THE BUSINESS ACTIVITY FOR SAID ORGANIZATION IS AS FOLLOWS:
WE WILL BE
PROVIDING FREE SKATEBOARDING, ROLLER SKATING AND ROLLER BALDING
LESSON'S TO LESS
FORTUNATE CHILDREN.

ARTICLE IV

THIS
CORPORATION SHALL NOT PARTICIPATE IN, OR INTERVENE IN (INCLUDING THE
PUBLISHING
OR DISTRIBUTION OF STATEMENTS), ANY POLITICAL CAMPAIGN ON BEHALF OF
OR IN
OPPOSITION TO ANY CANDIDATE FOR PUBLIC OFFICE. NOTWITHSTANDING ANY
OTHER
PROVISION OF THIS DOCUMENT, THE CORPORATION SHALL NOT CARRY ON ANY
OTHER
ACTIVITIES NOT PERMITTED TO BE CARRIED ON (A) BY A CORPORATION
EXEMPT FROM
FEDERAL INCOME TAX UNDER SECTION 501(C) (3) OF THE INTERNAL REVENUE
CODE, OR
THE CORRESPONDING SECTION OF ANY FUTURE FEDERAL TAX CODE, OR (B) BY
A
CORPORATION, CONTRIBUTIONS TO WHICH ARE DEDUCTIBLE UNDER SECTION
170(C) (2) OF
THE INTERNAL REVENUE CODE, OR THE CORRESPONDING SECTION OF ANY
FUTURE FEDERAL
TAX CODE.

COUNTY IN WHICH THE PRINCIPAL OFFICE OF THE ORGANIZATION IS THEN
LOCATED.

COURT SHALL DETERMINE, WHICH ARE ORGANIZED AND OPERATED
EXCLUSIVELY FOR SUCH
PURPOSES.
