**Non-Profit Corporation
Articles of Incorporation**

(Chapter 7-6-34 of the General Laws of Rhode Island, 1956, as amended)

ARTICLE I

The name of the corporation is The Business League

ARTICLE II

The period of its duration is X Perpetual

ARTICLE III

The specific purpose or purposes for which the corporation is organized are:

TO SERVE ITS MEMBERS AND BUSINESS COMMUNITY IN PROMOTING BUSINESS
AND ECONOMIC DEVELOPMENT.

ARTICLE IV

Provisions, if any, not inconsistent with the law, which the incorporators elect to set forth in these articles of incorporation for the regulation of the internal affairs of the corporation are:

FOURTH: PROVISIONS FOR THE REGULATION OF THE INTERNAL AFFAIRS OF THE
CORPORATION, INCLUDING PROVISIONS FOR THE DISTRIBUTION OF ASSETS ON
DISSOLUTION OR FINAL LIQUIDATION, ARE:

THE BUSINESS LEAGUE (THE "CORPORATION") IS ORGANIZED AS A TAX-EXEMPT
ORGANIZATION WITHIN THE MEANING OF SECTION 501(C)(6) OF THE UNITED
STATES INTERNAL REVENUE CODE OF 1986, AS AMENDED (THE "CODE"), AND IS
SUBJECT TO THE FOLLOWING LIMITATIONS UNDER THIS ARTICLE FOURTH:

1. THE CORPORATION IS NOT ORGANIZED FOR PROFIT AND IT SHALL NOT HAVE
ANY POWER TO ISSUE CERTIFICATES OF STOCK OR TO PAY DIVIDENDS.

2. NOTWITHSTANDING ANY OTHER PROVISIONS OF THESE ARTICLES OF
INCORPORATION, THE CORPORATION IS ORGANIZED EXCLUSIVELY AS A BUSINESS
LEAGUE.

3. IN THE EVENT OF DISSOLUTION, TERMINATION, OR FINAL LIQUIDATION OF THE

CORPORATION, WHETHER VOLUNTARY, INVOLUNTARY, OR BY OPERATION OF LAW, AND AFTER PAYMENT OF OR MAKING PROVISION FOR ALL THE CORPORATION'S DEBTS AND LIABILITIES OF EVERY NATURE AND DESCRIPTION, THE BOARD OF DIRECTORS SHALL DISPOSE OF ALL REMAINING ASSETS OF THE CORPORATION EXCLUSIVELY FOR THE LAWFUL PURPOSES OF THE CORPORATION IN SUCH MANNER OR TO SUCH OTHER ORGANIZATIONS AS SHALL AT THE RELEVANT TIME BE PERMITTED FOR ORGANIZATIONS OF THIS TYPE PURSUANT TO LAW. ANY SUCH ASSETS NOT SO DISPOSED OF SHALL BE DISPOSED OF BY A COURT OF COMPETENT JURISDICTION EXCLUSIVELY FOR THE LAWFUL PURPOSES OF THE CORPORATION IN SUCH MANNER OR TO SUCH OTHER ORGANIZATIONS AS SHALL AT THE RELEVANT TIME BE PERMITTED FOR ORGANIZATIONS OF THIS TYPE PURSUANT TO LAW.

4. NO PART OF THE NET EARNINGS OF THE CORPORATION SHALL INURE TO THE BENEFIT OF OR BE DISTRIBUTABLE TO ITS DIRECTORS, OFFICERS, OR OTHER PRIVATE PERSONS, EXCEPT THAT THE CORPORATION SHALL BE AUTHORIZED TO PAY REASONABLE COMPENSATION FOR SERVICES RENDERED AND TO MAKE PAYMENTS AND DISTRIBUTIONS IN FURTHERANCE OF ITS NON-PROFIT STATUS AS SET FORTH IN THESE ARTICLES. NO SUBSTANTIAL PART OF THE ACTIVITIES OF THE CORPORATION SHALL BE THE CARRYING ON OF PROPAGANDA OR OTHERWISE ATTEMPTING TO INFLUENCE LEGISLATION, AND THE CORPORATION SHALL NOT PARTICIPATE OR INTERVENE IN (INCLUDING THE PUBLISHING OR DISTRIBUTION OF STATEMENTS) AND POLITICAL CAMPAIGN ON BEHALF OF OR IN OPPOSITION TO ANY CANDIDATE FOR PUBLIC OFFICE.

5. PURSUANT TO R.I.G.L. § 7-6-15, AS AMENDED, THE CORPORATION SHALL HAVE NO MEMBERS, AND ALL OF THE POWERS, RIGHTS, AND DUTIES NORMALLY VESTED IN THE MEMBERS SHALL INSTEAD BE VESTED IN THE BOARD OF DIRECTORS OF THE CORPORATION.
