Articles of Incorporation**

(Chapter 7-6-34 of the General Laws of Rhode Island, 1956, as amended)

ARTICLE I

The name of the corporation is Enrichment Experience

ARTICLE II

The period of its duration is Perpetual

ARTICLE III

The specific purpose or purposes for which the corporation is organized are:

ENRICHMENT EXPERIENCE WILL PROVIDE OPPORTUNITIES FOR ELEMENTARY STUDENTS TO PARTICIPATE IN ORGANIZED AND EXCITING LEARNING ACTIVITIES OUTSIDE OF SCHOOL. THE ORGANIZATION AIMS TO CREATE A FUN AND ENRICHING LEARNING ENVIRONMENT FOR STUDENTS AFTER-SCHOOL AND DURING THE SUMMER. STUDENTS WILL EXPAND THEIR KNOWLEDGE OF MATH, SCIENCE, ENGLISH LANGUAGE ARTS, AND MORE THROUGH EXCITING AND EXPLORATIVE ACTIVITIES.

ARTICLE IV

Provisions, if any, not inconsistent with the law, which the incorporators elect to set forth in these articles of incorporation for the regulation of the internal affairs of the corporation are:

THIS CORPORATION IS ORGANIZED EXCLUSIVELY FOR CHARITABLE, LITERARY, AND EDUCATIONAL PURPOSES, INCLUDING FOR SUCH PURPOSES THE MAKING OF DISTRIBUTIONS TO ORGANIZATIONS THAT QUALIFY UNDER SECTION 501(C)(3) OF THE INTERNAL REVENUE CODE OR ANY CORRESPONDING SECTION OF ANY FUTURE FEDERAL TAX CODE. NO CORPORATION PROCEEDS WILL ENRICH ANY INDIVIDUAL,

EXCEPT THAT
REASONABLE COMPENSATION MAY BE PAID IN EXCHANGE FOR SERVICES TO THE
CORPORATION. IF THE CORPORATION IS DISSOLVED, ANY ASSETS REMAINING
WILL BE
DISTRIBUTED TO ANOTHER CORPORATION THAT SERVES A SIMILAR PURPOSE
AND
QUALIFIES AS A TAX-EXEMPT, CHARITABLE ORGANIZATION UNDER THE
PROVISIONS OF
501(C)(3) OF THE INTERNAL REVENUE CODE.
