Dear Mr. Alhakim:

The Office of the Attorney General has received your request to waive or reduce Zina International Inc. late fee for a delay in submitting its 2017-2023 annual reports. The reason stated for your request is you filed the articles of dissolution in 2016 but it was never reflected in the Secretary of States database.

Pursuant to R.I. Gen. Laws § 7-1-23, the Attorney General may “compromise” any penalty and permit the payment of a “smaller sum” than what has been assessed. There is, however, no provision for complete waiver of fees.

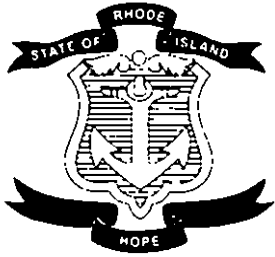
After reviewing the information that you provided to this Office and having found no consumer complaints or lawsuits against this company, this letter is to inform you that the Attorney General authorizes a reduction from \$300.00 to \$30.00. This is contingent, however, on the entity submitting the 2017-2023 annual reports to the Secretary of State and paying the filing fees.
