Attachment to Rhode Island Certificate of Authority – Let Love International Inc.

Article Sixth - Purpose

Let Love International Inc.'s mission is to protect the physical well-being, dignity, health, welfare, and safety of the marginalized children of the world. We strive to provide clean, safe and secure housing for neglected and abused orphans and "street children" along with providing day care and education to children of extreme need.

Let Love International is organized exclusively for charitable and educational purposes including, for such purposes, the making of distributions to organizations that qualify as except organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code. No part of the net earnings of Let Love International Inc. shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in the purpose clause hereof.

Notwithstanding any other provision of this document, the corporation shall not carry on any other activities not permitted to be carried on (a) by any organization exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, corresponding section of any future federal tax code, or (b) by any organization, contributions to which are deductible under section 170 (c)(2) of the Internal Revenue Code, or corresponding section of any future federal tax code.

Let Love International Inc. is not organized and shall not be operated for the private gain of any person. The property of the corporation is irrevocably dedicated to its education and charitable purpose. No part of the assets, receipts, or net earnings of the corporation shall inure to the benefit of, or be distributed to any individual. The corporation may, however, pay reasonable compensation for services rendered, and make other payments and distributions consistent with the Articles of Incorporation.
