This cause came on to be heard upon Plaintiffs, John DelRicci, Sunshine B. Mongeau, Jeffrey DelRicci and Eric DelRicci (collectively, the "Plaintiffs") and Defendants, Leslie J. McDevitt, Twins Pizza, Inc. ("TP") and Twin Del-Realty Co., Inc. ("TDR"), and each of them, collectively on the request to discharge the Temporary Special Master and dismiss all claims and, upon consideration, and by agreement of the parties, it is hereby

ORDERED, ADJUDGED & DECREED

- 1. That the parties no longer have any need for a Special Master in the within proceedings.
- 2. That the parties represent that all known claims, including all administrative, secured, priority tax, and general unsecured claims, against the Special Mastership Estate have been satisfied by the parties.
- 3. That Giovanni La Terra Bellina, Esq., Temporary Special Master (the "Special Master") of TP and TDR (collectively, the "Defendants"), agrees to the release as Special Master.
- 4. That said Special Master is hereby discharged and the Special Mastership Bond ordered cancelled.
- 5. That the assets, books and records of the Defendants shall be returned to the Defendants by the Special Master.
- 6. That the Special Master is directed to forward and file a copy of this order to the Office of the Secretary of State for the State of Rhode Island.
- 7. The Special Mastership proceeding is now closed and may be reopened only upon the filing of a Motion.
