This letter responds to your recent request to exercise certain fiduciary activities in the State of Rhode Island by a non-Rhode Island trust company. The authorizing statute, R. I. Gen. Laws § 19-3.1-6, which states that a bank or trust company located in another state may act in a fiduciary capacity under any written instrument in which it is named, appointed by any court of competent jurisdiction of the State of Rhode Island, or appointed by any probate court of Rhode Island, has been interpreted by the Division of Banking ("Division") to mean that only passive fiduciary activity is permitted.

First State Trust Company has submitted to this Division all required information in order to exercise those activities permitted by R. I. Gen. Laws § 19-3.1-6.

The appointment of Agent is deemed effective as of October 30, 2023, and the Division has no objection to First State Trust Company exercising the activities permitted by R. I. Gen. Laws § 19-3.1-6. I will be happy to respond to any questions you may have regarding this matter.
