





PURCHASE AND SALES AGREEMENT

This Agreement made this 30 day of September, 2023, by and between **Impress Cleaners, Inc.** a corporation duly organized and existing under the laws of the State of Rhode Island (hereinafter the "Seller") and, **Henry Mejia Productions, LLC** a limited liability company organized and existing under the laws of the State of Rhode Island (hereinafter the "Buyer").

WITNESSETH:

WHEREAS, the Seller is the owner and operator of a dry cleaning business, located at 280 Warwick Ave., Cranston, Rhode Island 02905; and

WHEREAS, the Seller is desirous of selling and the Buyer is desirous of buying the Seller's assets heretofore used in carrying on this business.

NOW, THEREFORE, it is mutually covenanted and agreed as follows:

(1.) SALE OR PURCHASE OF ASSETS.

A. Parties' Commitments. The Seller hereby agrees to sell to the Buyer, and the Buyer hereby agrees to purchase from the Seller, subject to the terms and conditions of this Agreement, the properties described in subparagraph B below.

B. Description of Assets. The assets to which this Agreement applies (herein after referred to as "the Properties") are the following:

- 1. Tangible Personal Property and Inventory.** All the Seller's furniture, equipment (see Exhibit A attached hereto as Bill of Sale Deposit Receipt), fixtures, and supplies; all papers, computerized data bases and records in Seller's care, custody and control relating to operation of Seller's business, including customer lists, sales records, billing records, marking materials, financial records and inventory records and all other tangible personal property located at the referenced address, including inventory.
- 2. Licenses.** All of the Seller's Right, Title and Interest in the Existing Licenses for the Premises.
- 3. Rights.** The rights to the business name Impress Cleaners Inc., all trademarks, signs, the goodwill of Business and its value as a going concern; and

C. Price. For the foregoing properties, the Buyer agrees to pay the price of [REDACTED]. The purchase price is to be paid to the Seller in full at the time of closing.

D. Agreement not Severable. This Agreement is not severable, the Seller being bound to sell and the Buyer to buy all the properties enumerated in subparagraph B as set forth above.

BILL OF SALE

KNOW ALL MEN BY THESE PRESENTS, that IMPRESS CLEANERS, INC., a Rhode Island Corporation, of 250 Werruck Avenue, Cranston, Rhode Island 02906, first called the "Seller" in consideration of the sum of [REDACTED] paid by HENRY MEJIA PRODUCTIONS, LLC, a Limited Liability Company organized and existing under the laws of the State of Rhode Island, hereinafter called the "Buyer", the receipt whereof is hereby acknowledged, have hereby granted, bargained and sell, convey, transfer and deliver to the said Buyer the equipment, goods, chattels and inventory, now located at 250 Werruck Avenue, Cranston, Rhode Island as set forth in Exhibit "A", which is attached hereto and expressly made a part hereof.

TO HAVE AND TO HOLD the same unto Buyer, its successors and assigns forever.

And I, Carlos Santos, President of Impress Cleaners, Inc., hereby covenants with the Buyer that Seller is the lawful owner of said property, that the Seller has good right to sell said property, that said property is free from all encumbrances and that the Seller will defend and warrant the same against the lawful claims and demands of all persons.
