Elizabeth Kearns (VP), and David Cesaro (Treas), are the only original board members listed on the 501c3 legal document. Elizabeth Kearns, and David Cesaro, will no longer be involved with the business aspects of the SKDPA with the dissolution of the 501c3 entity.
