


**SIXTH AMENDMENT TO AMENDED AND RESTATED AGREEMENT
AND CERTIFICATE OF LIMITED PARTNERSHIP OF
SCITUATE VISTA ASSOCIATES**

THIS SIXTH AMENDMENT TO THE AMENDED AND RESTATED AGREEMENT AND CERTIFICATE OF LIMITED PARTNERSHIP OF SCITUATE VISTA ASSOCIATES, is made and entered into as of December 15, 2023 by and among SVGP LLC, a Rhode Island limited liability company, 1992 Alfred Carpiionato Trust Agreement – CA, and National Investments, Ltd., a Rhode Island corporation (collectively the “*Partners*”) and Crown Holdings II LLC, a Rhode Island limited liability company (the “*Incoming Partner*”).

WITNESSETH

WHEREAS, Scituate Vista Associates (the “*Partnership*”), was formed as a Rhode Island limited partnership by filing its Certificate of limited partnership with the Secretary of the State of Rhode Island on October 14, 1981, which Certificate was amended and restated by filing its Amended and Restated Agreement and Certificate of Limited Partnership, dated March 23, 1982, and filed with the Secretary of State of Rhode Island (the “*Secretary*”) on April 13, 1982, and which amended and restated agreement and certificate was amended by the Certificate of Amendment to Certificate of Limited Partnership dated August 10, 2005 and filed with the Secretary on August 18, 2005, further amended by the Second Amendment to Certificate and Agreement of Limited Partnership dated December 19, 2006, and filed with the Secretary on December 26, 2006, further amended by the Third Amendment to Certificate and Agreement of Limited Partnership dated December 19, 2006, and filed with the Secretary on December 26, 2006, further amended by the Fourth Amendment to Certificate and Agreement of Limited Partnership dated December 19, 2006, and filed with the Secretary on December 26, 2006, and further amended by the Fifth Amendment to Certificate and Agreement of Limited Partnership dated January 20, 2011, and filed with the Secretary on January 20, 2011 (collectively, the “*Partnership Agreement*”); and

WHEREAS, the Partnership Agreement remains in full force and effect; and

WHEREAS, the Partners desire to further amend the Partnership Agreement to admit the Incoming Partner to the Partnership as a general partner;

NOW THEREFORE, in consideration of the mutual covenants set forth herein, the parties hereto do hereby agree as follows:

1. That Crown Holdings II LLC, a Rhode Island limited liability company is hereby admitted as a general partner of the Partnership.
2. That SVGP LLC, a Rhode Island limited liability company and Crown Holdings II LLC, a Rhode Island limited liability company, shall be the general partners and their interests ("*Percentage Interest*") in the Partnership as general partners shall be as follows:

Crown Holdings II LLC – 1.00% General Partner
SVGP LLC – 98.00% General Partner
3. That 1992 Alfred Carpionato Trust Agreement – CA and National Investments, Ltd., a Rhode Island corporation, shall be the limited partners and their Percentage Interest shall be as follows

1992 Alfred Carpionato Trust Agreement – CA – .75% Limited Partner
National Investments, Ltd. – .25% Limited Partner
4. That all of the provisions of the Partnership Agreement, as amended, are hereby ratified and confirmed.


