Articles of Incorporation**

(Chapter 7-6-34 of the General Laws of Rhode Island, 1956, as amended)

ARTICLE I

The name of the corporation is LDS Parent Committee

ARTICLE II

The period of its duration is Perpetual

ARTICLE III

The specific purpose or purposes for which the corporation is organized are:

PURPOSE OF ORGANIZATION

SECTION 1. TO SUPPORT CHILDREN PARTICIPATING IN COMPETITIVE DANCE AND TO WORK WITH COACHES TO PROVIDE THE BEST POSSIBLE COMPETITIVE PROGRAM.

SECTION 2. TO PERPETUATE, INCREASE AWARENESS OF, AND CONTRIBUTE TO THE IMPROVEMENT OF THE SPORT OF DANCE IN RHODE ISLAND AND LOCAL COMMUNITIES.

SECTION 3. TO FOSTER NATIONAL AND INTERNATIONAL AMATEUR SPORTS COMPETITION AND DEVELOP AMATEUR ATHLETES FOR SUCH COMPETITION.

SECTION 4. A PURPOSE OF THE ASSOCIATION IS TO REDUCE OR ELIMINATE FINANCIAL OBSTACLES THAT MIGHT PREVENT COMPETITION BY LET'S DANCE STUDIO DANCERS.

SECTION 5. FURTHERMORE, THE PURPOSE SHALL BE THE NON-PROFIT PERFORMANCE OF

ACTIVITIES ALLOWED UNDER IRS RULES FOR 501(C)(3) CORPORATIONS. NOTWITHSTANDING ANY OTHER PROVISIONS OF THESE BY-LAWS, THE ASSOCIATION SHALL NOT CONDUCT NOR CARRY ON ANY ACTIVITIES NOT PERMITTED TO BE CONDUCTED OR CARRIED ON BY AN ORGANIZATION EXEMPT FROM TAXATION BY REASON OF BEING DESCRIBED IN SECTION 501 (C) (3) OF THE INTERNAL REVENUE CODE AND ITS REGULATIONS AS THEY NOW EXIST OR AS THEY HEREAFTER BE AMENDED.

SECTION 6. LIMITATIONS:

A) NO PART OF THE EARNINGS OF THE ASSOCIATION SHALL DIRECTLY BENEFIT OR BE DISTRIBUTED TO ITS MEMBERS, OFFICERS, OR OTHER PRIVATE PERSONS EXCEPT THAT THE ORGANIZATION SHALL BE AUTHORIZED AND EMPOWERED TO PAY REASONABLE COMPENSATION FOR SERVICES RENDERED AND TO MAKE PAYMENTS

IN FURTHERANCE OF THE PURPOSES SET FORTH IN ARTICLE II HEREOF.

B) NO PART OF THE ASSOCIATION'S EARNINGS SHALL INURE TO THE BENEFIT OF ANY MEMBER OR INDIVIDUAL.

C) NO OFFICER OF THE ASSOCIATION OR ANY PRIVATE INDIVIDUAL SHALL BE ENTITLED

TO SHARE IN THE DISTRIBUTION OF ANY OF THE CORPORATE ASSETS UPON DISSOLUTION OF THE ASSOCIATION. IF THE ASSOCIATION IS DISSOLVED, ALL OF ITS REMAINING ASSETS SHALL BE DISTRIBUTED BY THE BOARD OF DIRECTORS TO ANOTHER NOT FOR PROFIT ORGANIZATION TO BE SELECTED AND APPROVED BY THE

LDS PARENTS ASSOCIATION

D) NO SUBSTANTIAL PART OF THE ACTIVITIES OF THE ASSOCIATION SHALL BE THE CARRYING ON OF PROPAGANDA, OR OTHERWISE ATTEMPTING TO INFLUENCE LEGISLATION, AND THE ASSOCIATION SHALL NOT PARTICIPATE IN, OR INTERVENE IN ANY POLITICAL CAMPAIGN ON THE BEHALF OF ANY CANDIDATE FOR PUBLIC OFFICE.

ARTICLE IV

Provisions, if any, not inconsistent with the law, which the incorporators elect to set forth in these articles of incorporation for the regulation of the internal affairs of the corporation are:
