Dear Mr. Peters:

The Office of the Attorney General has received your request to waive or reduce Peters Realty, Inc.'s late fee for a delay in submitting its 2021-2023 annual reports. The reason stated for your request is your attorney failed to file the annual reports nor notify Peters Realty, Inc.
