Articles of Incorporation**

(Chapter 7-6-34 of the General Laws of Rhode Island, 1956, as amended)

ARTICLE I

The name of the corporation is LIFE OF PEACE CENTER

ARTICLE II

The period of its duration is Perpetual

ARTICLE III

The specific purpose or purposes for which the corporation is organized are:

THE CORPORATION/ORGANIZATION SHALL BE OPERATED EXCLUSIVELY FOR/TO PROVIDED MENTAL HEALTH SERVICES AND SOCIAL SERVICES TO THE COMMUNITY. IN ADDITION, THE CORPORATION/ORGANIZATION HAS BEEN FORMED FOR THE PURPOSE OF PERFORMING ALL THINGS INCIDENTAL TO, OR APPROPRIATE IN, FOREGOING SPECIFIC AND PRIMARY PURPOSES. HOWEVER, THE CORPORATION/ORGANIZATION SHALL NOT, EXCEPT TO AN INSUBSTANTIAL DEGREE, ENGAGE IN ANY ACTIVITY OR THE EXERCISE OF ANY POWERS WHICH ARE NOT IN FUTUREANCE OF ITS PRIMARY NON-PROFIT PURPOSES.

ARTICLE IV

Provisions, if any, not inconsistent with the law, which the incorporators elect to set forth in these articles of incorporation for the regulation of the internal affairs of the corporation are:
