ARTICLE 2: PURPOSE

1. GENERAL PURPOSE. THE CRANSTON STREET HOCKEY LEAGUE IS ORGANIZED AND

OPERATED FOR THE FOLLOWING GENERAL PURPOSES:

A) EXCLUSIVELY AS A QUALIFIED AMATEUR SPORTS ORGANIZATION WITHIN THE MEANING OF '501(C)(3) OF THE INTERNAL REVENUE CODE OF 1986 (AS AMENDED)

OR

THE CORRESPONDING PROVISION OF ANY FUTURE UNITED STATES INTERNAL REVENUE

LAW, INCLUDING FOR SUCH PURPOSES, THE MAKING OF DISTRIBUTIONS TO ORGANIZATIONS WHICH ARE RECOGNIZED AS EXEMPT FROM TAX UNDER SUCH '501(C)

(3).

B) TO EXERCISE SUCH RIGHTS, POWERS, DUTIES, AND AUTHORITY OF A NONPROFIT

CORPORATION ORGANIZED UNDER THE NONPROFIT CORPORATION ACT OF THE STATE OF

RHODE ISLAND WHICH ARE CONSISTENT WITH THE PRECEDING PARAGRAPH.

2. SPECIFIC PURPOSES. THE SPECIFIC PURPOSES OF THE CRANSTON STREET HOCKEY

LEAGUE INCLUDE, WITHOUT LIMITATION, ARE THE FOLLOWING:

A) PROVIDE A COMMUNITY WITH AN ORGANIZATION AND FACILITIES THAT WILL ALLOW

PARTICIPANTS AN EQUAL OPPORTUNITY TO PARTICIPATE IN THE SPORT OF STREET

HOCKEY, PICKLEBALL AND OTHER SPORTING EVENTS BY ORGANIZING LEAGUES, TOURNAMENTS, AND OPEN PLAY PROGRAMS.

B) RAISE FUNDS NECESSARY TO PROVIDE AFFORDABLE PROGRAMS FOR ALL PARTICIPANTS, AND TO MAINTAIN AND IMPROVE ORGANIZATION FACILITIES.

**ARTICLE III**
