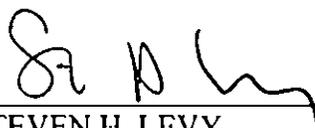

It appeared that the shareholders were present and had signed a waiver of notice of this meeting, which is annexed hereto.

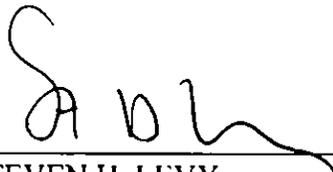

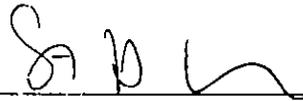
