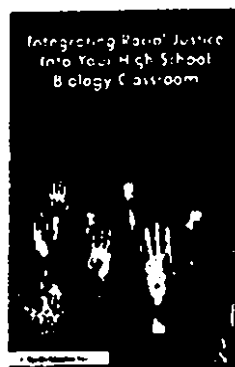

This illegal use of my identity came to light because Citizens Bank called to ask if I wanted to open a business account, since I had registered a business under the name of "Phones and Sims Corp."
