Articles of Incorporation**

(Chapter 7-6-34 of the General Laws of Rhode Island, 1956, as amended)

ARTICLE I

The name of the corporation is P.E.A.C.E Organization

ARTICLE II

The period of its duration is Perpetual

ARTICLE III

The specific purpose or purposes for which the corporation is organized are:

TO PROVIDE LOW-INCOME FAMILIES TEMPORARY MONETARY RELIEF WHEN
REOCCURRING OR
UNFORESEEN CIRCUMSTANCES CAUSE FINANCIAL INSTABILITY; WHILE
OFFERING CLIENTS
RESOURCES TO GENERATE PERMANENT SOLUTIONS TO ACHIEVING ECONOMIC
STABILITY AND
INDEPENDENCE.

ARTICLE IV

Provisions, if any, not inconsistent with the law, which the incorporators elect to set forth in these articles of incorporation for the regulation of the internal affairs of the corporation are:

THE P.E.A.C.E. ORGANIZATION SHALL HOLD AND MAY EXERCISE ALL SUCH
POWERS AS
MAY BE CONFERRED UPON ANY NONPROFIT ORGANIZATION BY THE LAWS OF
THE STATE
OF RHODE ISLAND AND AS MAY BE NECESSARY OR EXPEDIENT FOR THE
ADMINISTRATION
OF THE AFFAIRS AND ATTAINMENT OF THE PURPOSES OF THE
CORPORATION/ORGANIZATION. AT NO TIME AND IN NO EVENT SHALL THE
P.E.A.C.E.
ORGANIZATION PARTICIPATE IN ANY ACTIVITIES THAT HAVE NOT BEEN
PERMITTED TO
BE CARRIED OUT BY A CORPORATION/ORGANIZATION EXEMPT UNDER SECTION

501(C) OF THE INTERNAL REVENUE CODE OF 1986 (THE CODE"), SUCH AS CERTAIN POLITICAL AND LEGISLATIVE ACTIVITIES.
THE PROPERTIES AND ASSETS OF THE P.E.A.C.E. ORGANIZATION ARE IRREVOCABLY DEDICATED TO AND FOR NONPROFIT PURPOSES ONLY. NO PART OF THE NET EARNINGS, PROPERTIES, OR ASSETS OF THIS CORPORATION/ORGANIZATION ON DISSOLUTION OR OTHERWISE, SHALL INURE TO THE BENEFIT OF ANY PERSON OR ANY MEMBER, DIRECTOR, OR OFFICER OF THIS CORPORATION/ORGANIZATION. ON LIQUIDATION OR DISSOLUTION, ALL REMAINING PROPERTIES AND ASSETS OF THE P.E.A.C.E. ORGANIZATION SHALL BE DISTRIBUTED AND PAID OVER TO AN ORGANIZATION DEDICATED TO NONPROFIT PURPOSES THAT HAS ESTABLISHED ITS TAX-EXEMPT STATUS PURSUANT TO SECTION 501(C) OF THE CODE.
