


On March 8, 2024, I sent a letter to you indicating that due to your nonpayment of legal fees dating back to early 2022, I could not continue to represent you and I was resigning as Resident Agent for Iron Rock Realty, LLC. At that time, I enclosed a Rhode Island Secretary of State Form 642 Statement of Change of Agent and had asked you to sign, date and submit said form to the Rhode Island Secretary of State; however you have not filed said form with the Rhode Island Secretary of State; therefore, pursuant to Rhode Island General Laws §7-6-11, I am enclosing herewith a Resignation of Registered Agent for my resignation as Resident Agent for Iron Rock Realty, LLC. Said form is being mailed today to the Secretary of State and will become effective on the thirtieth (30) day after their receipt of said resignation.

I suggest that you either find a new Resident Agent or you complete the forms to become the new Resident Agent for your limited liability company.

Finally, as previously stated in my prior letter, your 2024 Annual Report was due to be filed with the Rhode Island Secretary of State prior to May 1. To date I note that your Report has not been filed. It is imperative that you file said report so that you do not incur a penalty fee and your limited liability company will remain in good standing with said Secretary of State.
