### RECEIVERSHIP NOTICE

Please take notice that on May 28, 2024, an Order Appointing Temporary Liquidating Receiver was entered by the Providence Superior Court in the above captioned matter. Said Order appointed Tricia Bielinski as Temporary Liquidating Receiver (the "Receiver") of Clean Ocean Access (the "Respondent").

Said Order, the original of which, is on file in the Office of the Clerk of the Providence County Superior Court, and which Order is incorporated herein by reference as if it were set forth in full in this Receivership Notice, contains, inter alia, the following provisions:

"1. That Tricia Bielinski be and hereby is appointed Temporary Liquidating Receiver (the "Liquidating Receiver") of the Corporation, and of all the estate, assets, effects, property and business of the Corporation of every name, kind, nature and description, with all the powers of a temporary receiver as set forth herein. On such notice as may be required, if any, the Liquidating Receiver may apply to this Court for enhanced powers other than those powers specifically enumerated or otherwise set forth herein.

2. William M. Dolan, III and the law firm of Adler, Pollock & Sheehan, P.C. (the "Firm") shall be hereby appointed by the Court as counsel to the Liquidating Receiver. Inquiries concerning this Notice and this matter may be directed to counsel for the Liquidating Receiver, William M. Dolan III, as set below.

That Notice be given of the entry of this Order by the Liquidating Receiver by mailing on or before the 18<sup>th</sup> day of June, 2024, a copy of this Order Appointing Liquidating Receiver to each creditor and stockholder of said Corporation known as such to the Liquidating Receiver, or appearing as such on the books of said Corporation, addressed to each such interested party or creditor at his last known address. Further, a citation shall be issued to said Respondent, returnable to the Superior Court sitting at Providence, Rhode Island on June 28, 2024 at 9:30 a.m., remotely via Webex, at which time and place this cause is set down for Hearing on the prayer for the Appointment of a Permanent Liquidating Receiver; that the Clerk of this Court shall give Notice once in The Providence Journal on or before June 18, 2024, and the Liquidating Receiver shall give further notice as aforesaid."
