(Chapter 7-6-34 of the General Laws of Rhode Island, 1956, as amended)

ARTICLE I

The name of the corporation is Libertarian Mutual Aid, Inc

ARTICLE II

The period of its duration is Perpetual

The specific purpose or purposes for which the corporation is organized are:

ITS DEBTS AND LIABILITIES, ALL OF THE REMAINING FUNDS, ASSETS, AND
PROPERTIES OR PROCEEDS OF SALE THEREOF, OF THIS NON-PROFIT SHALL BE
DONATED
AND PAID TO ANOTHER NON-PROFIT OR AS DIRECTED BY THE ATTORNEY
GENERAL. IN
THE EVENT THERE IS NO OTHER NON-PROFIT IDENTIFIED, THE FUNDS WILL BE
DONATED TO THE RHODE ISLAND FOUNDATION.

CORPORATE OFFICERS AND DIRECTORS SHALL BE INDEMNIFIED BY THIS
NON-PROFIT

FOR ANY ACTIONS OR LACK OF ACTIONS TO THE FULLEST EXTENT OF THE LAW.
