Articles of Incorporation**

(Chapter 7-6-34 of the General Laws of Rhode Island, 1956, as amended)

ARTICLE I

The name of the corporation is WRITE

ARTICLE II

The period of its duration is Perpetual

ARTICLE III

The specific purpose or purposes for which the corporation is organized are:

TO PROMOTE THE IMPORTANCE OF WRITING AS A FOUNDATIONAL SKILL FOR
EDUCATION AND PERSONAL DEVELOPMENT.

TO ENCOURAGE AND SUPPORT DEVELOPING WRITERS BY AWARDING
SCHOLARSHIPS AND FINANCIAL ASSISTANCE TO HELP
THEM PURSUE EDUCATIONAL AND CREATIVE OPPORTUNITIES.

TO OFFER RESOURCES, MENTORSHIP, AND GUIDANCE TO HELP DEVELOPING
WRITERS DEVELOP THEIR SKILLS AND
EXPRESS THEIR UNIQUE VOICES.

ARTICLE IV

Provisions, if any, not inconsistent with the law, which the incorporators elect to set forth in these articles of incorporation for the regulation of the internal affairs of the corporation are:

THE CORPORATION SHALL HAVE NO MEMBERS. THE MANAGEMENT AND
AFFAIRS OF THE CORPORATION SHALL BE
UNDER THE DIRECTION OF THE BOARD OF DIRECTORS, AS DEFINED BY THE
CORPORATION'S BYLAWS.

THE BOARD OF DIRECTORS SHALL HAVE THE POWER TO ADOPT, AMEND, OR
REPEAL THE BYLAWS OF THE CORPORATION.

DIRECTORS SHALL SERVE WITHOUT COMPENSATION, EXCEPT THAT THEY MAY
BE REIMBURSED FOR REASONABLE

EXPENSES INCURRED IN THE PERFORMANCE OF THEIR DUTIES.

THE BOARD OF DIRECTORS MAY ESTABLISH SUCH COMMITTEES AS DEEMED NECESSARY AND APPROPRIATE TO CONDUCT THE AFFAIRS OF THE CORPORATION. EACH COMMITTEE SHALL HAVE THE AUTHORITY AND RESPONSIBILITIES AS DETERMINED BY THE BOARD OF DIRECTORS.
