

### 3.01 Purpose

Ministerio Pan De Vida is a non-profit corporation and shall operate exclusively for religious, educational and charitable purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future Federal tax code. Ministerio Pan De Vida's purpose is to reach out to the lost (souls) and the hungry (for the Truth). We take the commission that our Lord and Savior, Jesus the Christ, gave to His disciples (Matthew 28:16-20) to evangelize to the community and "unto the ends of the earth."; making disciples of others for the growth of the Kingdom of Heaven on earth.

Also, our purpose includes sending out ambassadors to raise social and spiritual consciousness about the cause on a local and global level, and to hold fundraising events in order to provide immediate relief and assistance to those suffering from chronic malnutrition and hunger regardless of their race, age, sex, ethnicity, or religion.

To maximize our impact on current efforts, we may seek to collaborate with other non-profit organizations which fall under Section 501(c)(3) of the Internal Revenue Code and are operated exclusively for educational and charitable purposes.

Our Vision: Loving and educating the followers of Jesus Christ to be good neighbors and citizens of this nation. Worshiping God, evangelizing His Word through the Holy Scriptures that are found in the Bible, applying biblical truth, so that God's will may be done on earth as it is in heaven.

Reaching the souls for salvation through Jesus Christ.

### 3.02 Public Benefit

Ministerio Pan De Vida is designated as a public benefit organization.

### 4.01 Non-profit Nature

Ministerio Pan De Vida is organized exclusively for religious, educational and charitable purposes including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future Federal tax code. No part of the net earnings of Ministerio Pan De Vida shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in the purpose clause hereof.

Notwithstanding any other provision of this document, the corporation shall not carry on any other activities not permitted to be carried on (a) by any organization exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future Federal tax code, or (b) by an organization, contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code, or corresponding section of any future Federal tax code.

Ministerio Pan De Vida is not organized and shall not be operated for the private gain of any person. The property of the corporation is irrevocably dedicated to its religious, educational and charitable purposes. No part of the assets, receipts, or net earnings of the corporation shall inure to the benefit of, or be distributed to any individual. The corporation may, however, pay reasonable compensation for services rendered, and make other payments and distributions consistent with these Articles.

#### 4.02 Personal Liability

No officer or director of this corporation shall be personally liable for the debts or obligations of Ministerio Pan De Vida of any nature whatsoever, nor shall any of the property or assets of the officers or directors be subject to the payment of the debts or obligations of this corporation.

#### 4.03 Dissolution

Upon termination or dissolution of Ministerio Pan De Vida, any assets lawfully available for distribution shall be distributed to one(1) or more qualifying organizations described in Section 501(c)(3) of the Internal Revenue Code of 1986 (or described in any corresponding provision of any successor statute) which organization or organizations have a charitable purpose which, at least generally, includes a purpose similar to the terminating or dissolving corporation.

The organization to receive the assets of Ministerio Pan De Vida hereunder shall be selected by the discretion of a majority of the managing body of Ministerio Pan De Vida, and if its members cannot so agree, then the recipient organization shall be selected pursuant to a verified petition in equity filed in a court of proper jurisdiction against Ministerio Pan De Vida by one(1) or more of its managing body which verified petition shall contain such statements as reasonably indicated the applicability of this section. The court upon finding that this section is applicable shall select the qualifying organization or organizations to receive the assets to be distributed, giving preference if practicable to organizations located within the State of Rhode Island.

In the event that the court shall find that this section is applicable but that there is no qualifying organization known to it which has a charitable purpose, which, at least generally, includes a purpose similar to this corporation, then the court shall direct the distribution of its assets lawfully available for distribution to the Treasurer of the State of Rhode Island to be added to the general fund.

#### 4.04 Prohibited Distributions

No part of the net earnings, or properties of this corporation, on dissolution or otherwise, shall inure to the benefit of, or be distributable to, its members, directors, officers or other private persons or individual, except that the corporation shall be authorize and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article III, Section 3.01.

#### 4.05 Restricted Activities

No substantial part of the corporation's activities shall be carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene (including the publishing or distribution of statements) in any political campaign on behalf of or in opposition to any candidate for public office.

#### 4.06 Prohibited Activities

Notwithstanding any other provision of these Articles, the corporation shall not carry on any activities not permitted to be carried on (I) by a corporation exempt from federal income tax as an organization described by Section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (II) by a corporation, contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.
