ARTICLE I

The name of the limited liability company is: SEED PENNY VENTURES LLC

THE LLC IS NO LONGER REQUIRED FOR ITS ORIGINAL PURPOSE, AND THE DECISION WAS MADE BY THE MEMBERS TO DISSOLVE THE ENTITY.
