(Chapter 7-6-34 of the General Laws of Rhode Island, 1956, as amended)

ARTICLE I

The name of the corporation is Historic North Kingstown

ARTICLE II

The period of its duration is Perpetual

ARTICLE III

The specific purpose or purposes for which the corporation is organized are:

THE PURPOSE OF HNK IS TO PROMOTE PRESERVATION OF NORTH KINGSTOWN'S HISTORY THROUGH THE ESTABLISHMENT OF A COLLECTION OF ARCHIVES, AND TO PROMOTE EDUCATION BY SHARING THE STORIES BEHIND THESE HISTORICAL DOCUMENTS AND ARTIFACTS. BY COLLABORATING WITH OTHER GROUPS, HNK WILL CELEBRATE NORTH KINGSTOWN'S PAST FROM ITS INDIGENOUS BEGINNINGS THROUGH THE DEVELOPMENT OF THE EIGHT HISTORICAL VILLAGES. ALLENTON, DAVISVILLE, HAMILTON, LAFAYETTE, QUONSET/QUIDNESSET, SAUNDERSTOWN, SLOCUM, AND WICKFORD ALL BRING THEIR OWN UNIQUE CONTRIBUTION TO THE HISTORY OF NORTH KINGSTOWN; AND THEIR STORIES NEED TO BE PRESERVED AND TOLD.
