ESTABLISH ANNUAL FUNDING GOALS BASED ON PROJECTED FISCAL YEAR APPROPRIATIONS

AND ANY SCHOLARSHIPS. FUNDRAISING GOALS WILL BE ESTABLISHED AND SHARED WITH

THE BOARD AND CLUB EACH FISCAL YEAR.
