(Chapter 7-6-34 of the General Laws of Rhode Island, 1956, as amended)

**ARTICLE I**

The name of the corporation is Sandy Point Heritage Foundation

**ARTICLE II**

The period of its duration is  Perpetual

**ARTICLE III**

The specific purpose or purposes for which the corporation is organized are:

THIS CORPORATION IS ORGANIZED EXCLUSIVELY FOR CHARITABLE,  
EDUCATIONAL, AND  
CULTURAL PURPOSES UNDER  
SECTION 501(C)(3) OF THE INTERNAL REVENUE CODE OF 1986 (OR THE  
CORRESPONDING  
PROVISION OF ANY FUTURE  
UNITED STATES INTERNAL REVENUE LAW). THE SPECIFIC PURPOSES OF THE  
SANDY POINT  
HERITAGE FOUNDATION  
INCLUDE:  
TO PROMOTE AND CULTIVATE CULTURAL AND RECREATIONAL ACTIVITIES BY  
SUPPORTING  
EQUINE-RELATED PROGRAMS,  
CULTURAL EVENTS, AND MUSIC PROGRAMMING.  
TO PRESERVE AND REVITALIZE HISTORICALLY SIGNIFICANT PROPERTIES,  
INCLUDING BUT NOT  
LIMITED TO SANDY POINT  
STABLES, TO ENSURE THEY CONTINUE TO SERVE AS HUBS FOR COMMUNITY  
ENGAGEMENT,  
HERITAGE APPRECIATION,  
AND CULTURAL ENRICHMENT.  
TO FOSTER A DEEPER APPRECIATION FOR THE CULTURAL HERITAGE OF  
PORTSMOUTH, RHODE  
ISLAND, THROUGH THE

DEVELOPMENT OF PROGRAMS AND EVENTS THAT HIGHLIGHT THE HISTORICAL AND RECREATIONAL SIGNIFICANCE OF THE AREA.  
TO ENHANCE COMMUNITY INVOLVEMENT BY CREATING ACCESSIBLE AND SUSTAINABLE VENUES FOR EDUCATIONAL AND RECREATIONAL ACTIVITIES, SPECIFICALLY RELATED TO EQUESTRIAN SPORTS AND CULTURAL EVENTS.  
TO RAISE AWARENESS AND FUNDS TO SUPPORT THE LONG-TERM PRESERVATION OF SANDY POINT STABLES AND OTHER HISTORIC PROPERTIES.
