The purpose of this corporation is to support the North Cumberland Middle School Science Olympiad Team and Cumberland High School Science Olympiad Team by securing resources, mentorship and funding. Thus providing opportunities to the teams that may not otherwise be provided.
- 4. Provisions, if any, not consistent with the law, which the incorporation elect to set forth in these articles of Incorporation for the regulation of the internal affairs of the corporation are:

 No part of the net earnings of the corporation shal inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes described in section 501(c)(3). No substantial part of the activities of the corporation shall constitute the carrying on of propaganda or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in(including by publication or distribution of statement), any political campaign on behalf of, or in opposition to, any candidate for public office. Notwithstanding any other provisions of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code or corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or corresponding section of any future federal tax code.
