### ATTACHMENT TO ARTICLES OF INCORPORATION

#### CHIBI'S CHOICE DOG GROOMING, DAYCARE & SUPPLY OF WARWICK, INC.

#### **ARTICLE TWO:**

- (A) With respect to the issuance of shares, any and all preferences, limitations, relative rights, duties, obligations, class(es), series, and the like shall be governed by the Bylaws of the Corporation, as the same may be amended from time to time.
- (B) The shares of stock of the Corporation are subject to and transferable on the books of the Corporation only upon compliance with the provisions of the stock restrictions applicable thereto in the Bylaws of the Corporation, as the same may be amended from time to time, which include, without limitation, satisfaction of certain rights of first refusal with respect to the Corporation and other shareholders.

#### **ARTICLE FIVE**:

- (A) All internal affairs of the Corporation not otherwise provided in these Articles shall be governed by the Bylaws of the Corporation, as the same may be amended from time to time, in accordance therewith.
- (B) An officer or director of the Corporation shall not be personally liable to the Corporation or its shareholders for monetary damages for the breach of the officer's or director's duty as an officer or director, except for: (i) liability for any breach of the officer's or director's duty of loyalty to the Corporation or its shareholders; (ii) liability for acts or omissions not in good faith or which involve intentional misconduct or a knowing violation of law; (iii) liability imposed pursuant to the provisions R.I.G.L. Title 7, Chapter 1.2, et seq., known as the Rhode Island Business Corporation Act (the "Act"); or (iv) liability for any transaction (other than transactions approved in accordance with the Act, these Articles, or the Bylaws) from which the officer or director derived an improper personal benefit. If the Act is amended to authorize corporate action further eliminating or limiting the personal liability of officers or directors, then the liability of an officer or director shall be eliminated or limited to the fullest extent so permitted. Any repeal or modification of this provision by the Corporation shall not adversely affect any right or protection of an officer of the Corporation existing prior to such repeal or modification.
- (C) Any action, except as may be required by the Act or permitted to be taken at a meeting of shareholders may be taken without a meeting, without prior notice, and without a vote if consented to in writing by a majority of the holders of outstanding shares. Prompt notice of such actions shall be given to all shareholders who would have been entitled to vote upon such action if a meeting of shareholders were held.
