Articles of Incorporation**

(Chapter 7-6-34 of the General Laws of Rhode Island, 1956, as amended)

ARTICLE I

The name of the corporation is Atlantic Mobile Welding

ARTICLE II

The period of its duration is Perpetual

ARTICLE III

The specific purpose or purposes for which the corporation is organized are:

THE PURPOSE OF OUR NONPROFIT MOBILE WELDING ORGANIZATION INCLUDES:

- SKILL DEVELOPMENT: PROVIDING TRAINING AND WORKSHOPS FOR INDIVIDUALS

INTERESTED IN LEARNING WELDING SKILLS, PARTICULARLY IN UNDERSERVED COMMUNITIES.

- COMMUNITY PROJECTS: OFFERING WELDING SERVICES FOR COMMUNITY PROJECTS, SUCH AS BUILDING SHELTERS, PLAYGROUNDS, OR PUBLIC ART INSTALLATIONS.

- SUPPORT FOR LOCAL BUSINESSES: ASSISTING SMALL BUSINESSES OR ARTISANS WITH WELDING NEEDS AT A REDUCED COST OR THROUGH DONATIONS OF TIME AND MATERIALS.

- DISASTER RELIEF: RESPONDING TO EMERGENCIES BY PROVIDING WELDING SERVICES FOR REPAIRS IN AFFECTED AREAS, SUCH AS FIXING INFRASTRUCTURE AFTER NATURAL DISASTERS.

- MENTORSHIP AND EMPLOYMENT: CREATING MENTORSHIP OPPORTUNITIES AND JOB PLACEMENTS FOR INDIVIDUALS PURSUING CAREERS IN WELDING.

- PROMOTING SAFETY: EDUCATING THE COMMUNITY ON WELDING SAFETY PRACTICES AND PROVIDING SAFETY GEAR TO THOSE IN NEED.

- ENVIRONMENTAL RESPONSIBILITY: FOCUSING ON SUSTAINABLE PRACTICES IN WELDING, SUCH AS RECYCLING SCRAP METAL AND MINIMIZING WASTE.

ARTICLE IV

Provisions, if any, not inconsistent with the law, which the incorporators elect to set forth in these articles of incorporation for the regulation of the internal affairs of the corporation are:

THE AFFAIRS OF THE ORGANIZATION SHALL BE MANAGED BY A BOARD OF DIRECTORS.

THE INITIAL BOARD OF DIRECTORS SHALL CONSIST OF [NUMBER] MEMBERS WHOSE

UPON THE DISSOLUTION OF THIS ORGANIZATION, ASSETS SHALL BE DISTRIBUTED FOR

ONE OR MORE EXEMPT PURPOSES WITHIN THE MEANING OF SECTION 501(C)(3) OF THE

INTERNAL REVENUE CODE, OR SHALL BE DISTRIBUTED TO THE FEDERAL GOVERNMENT,

OR TO A STATE OR LOCAL GOVERNMENT, FOR A PUBLIC PURPOSE.

THESE ARTICLES MAY BE AMENDED BY A TWO-THIRDS VOTE OF THE BOARD
