Dear Tom:



You will have to retain a new registered agent and file their information with the Secretary of State using a Form 640 (available on the Secretary of State's website). You can serve as your own registered agent, retain another attorney to serve as your registered agent or engage the services of a company that serves as registered agents (i.e. Harbor Compliance, Northwest Registered Agent, Rhode Island Registered Agent).

You will also have to identify someone to file your annual reports. Your next annual report must be filed between February 1, 2025 and May 1, 2025. You can do this yourself, retain another attorney or a company that provides these services.

Please let me know when you have filed the change of registered agent.
