Articles of Incorporation**

(Chapter 7-6-34 of the General Laws of Rhode Island, 1956, as amended)

ARTICLE I

The name of the corporation is Guard Up Martial Arts

ARTICLE II

The period of its duration is Perpetual

ARTICLE III

The specific purpose or purposes for which the corporation is organized are:

STRATEGIES TO DEAL WITH BULLYING, REINFORCING THE IDEA THAT THEY ARE
NOT
ALONE AND CAN SEEK HELP.

CREATING SAFE SPACES: PROVIDE A SAFE AND SUPPORTIVE ENVIRONMENT WHERE PARTICIPANTS CAN SHARE THEIR EXPERIENCES, DISCUSS BULLYING, AND RECEIVE GUIDANCE FROM INSTRUCTORS AND PEERS.

FOSTERING EMPATHY: ENCOURAGE EMPATHY AND UNDERSTANDING AMONG PARTICIPANTS, HELPING THEM RECOGNIZE THE FEELINGS OF OTHERS AND PROMOTING KINDNESS AND INCLUSIVITY.

LEADERSHIP DEVELOPMENT: OFFER LEADERSHIP OPPORTUNITIES FOR OLDER STUDENTS TO MENTOR YOUNGER ONES, EMPOWERING THEM TO BE ADVOCATES AGAINST BULLYING IN THEIR SCHOOLS AND COMMUNITIES.

COMMUNITY PARTNERSHIPS: COLLABORATE WITH SCHOOLS, PARENTS, AND LOCAL ORGANIZATIONS TO EXTEND ANTI-BULLYING EFFORTS BEYOND THE DOJO, CREATING A UNIFIED FRONT AGAINST BULLYING IN THE COMMUNITY.

PROMOTION OF POSITIVE VALUES: INSTILL VALUES SUCH AS RESPECT, DISCIPLINE, AND COMPASSION, REINFORCING THE IDEA THAT TRUE STRENGTH COMES FROM KINDNESS AND RESPECT FOR OTHERS.

IMPACT ON SCHOOL CLIMATE: CONTRIBUTE TO A MORE POSITIVE SCHOOL ENVIRONMENT BY ENCOURAGING STUDENTS TO TAKE A STAND AGAINST BULLYING, CREATING A CULTURE OF SUPPORT AND ACCEPTANCE.
