

EXHIBIT A

ARTICLE V

1. <u>Authority of directors to create new classes and series of shares</u>. The board of directors, acting without the shareholders, may (a) reclassify any unissued shares of any authorized class or series into one or more existing or new classes or series, and (b) create one or more new classes or series of shares, specifying the number of shares to be included therein, the distinguishing designation thereof and the preferences, limitations and relative rights applicable thereto, provided that the board of directors may not approve an aggregate number of authorized shares of all classes and series which exceeds the total number of authorized shares specified in the Articles of Incorporation approved by the shareholders.

2. <u>Minimum number of directors</u>. The board of directors may consist of one or more individuals, notwithstanding the number of shareholders.

3. <u>Personal liability of directors to corporation</u>. No director shall have personal liability to the corporation for monetary damages for breach of his or her fiduciary duty as a director notwithstanding any provision of law imposing such liability, provided that this provision shall not eliminate or limit the liability of a director (a) for any breach of the director's duty of loyalty to the corporation or its shareholders, (b) for acts or omissions not in good faith or which involve intentional misconduct or a knowing violation of law, (c) for improper distributions under R.I. Gen. Laws § 7-1.2-614, or (d) for any transaction from which the director derived an improper personal benefit.

4. <u>Shareholder vote required to approve matters acted on by shareholders</u>. The affirmative vote of a majority of all the shares in a voting group eligible to vote on a matter shall be sufficient for the approval of the matter, notwithstanding any greater vote on the matter otherwise required by any provision of Title 7 Chapter 1.2 of the General Laws of Rhode Island.

5. <u>Shareholder action without a meeting by less than unanimous consent</u>. Action required or permitted by Title 7 Chapter 1.2 of the General Laws of Rhode Island to be taken at a shareholders' meeting may be taken without a meeting by shareholders having not less than the minimum number of votes necessary to take the action at a meeting at which all shareholders entitled to vote on the action are present and voting.

6. <u>Authorization of directors to make, amend or repeal bylaws</u>. The board of directors may make, amend or repeal the bylaws in whole or in part, except with respect to any provision thereof which by virtue of an express provision in Title 7 Chapter 1.2 of the General Laws of Rhode Island, the Articles of Incorporation or the bylaws requires action by the shareholders.
