## EXHIBIT A TO ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF RESH, INC.

- 1. The capitalization of the Corporation in hereby modified to covert the existing common stock of the Corporation to two classes of stock as follows: (i) Voting Common Stock designated as Class A Voting Common Stock which shall consist of 1,000 authorized shares; and (ii) Non-Voting Common Stock designated as Class B Non-Voting Common Stock which shall consist of 9,000 authorized shares. All voting rights of the shareholders of the Corporation shall be vested in the Class A Voting Common Stock.
- 2. To the extent that the Rhode Island Business Corporation Act (the "Act") requires a vote by all the shareholders of the Corporation, the number of votes of all of the shareholders holding Class A Voting Common Stock shall be one thousand (1,000). The total number of votes of the shareholders holding Class A Voting Common Stock shall be allocated among such shareholder in accordance with their percentage interests in the Class A Voting Common Stock.
- 3. To the extent that the Act requires a vote by all the shareholders of the Corporation, any vote by the shareholders holding Class B Non-Voting Common Stock on matters upon which shareholders are entitled to vote, except as otherwise required by law, will be together with the shareholders holding Class A Voting Common Stock, as a single class and not as a separate class, and each shareholders holding Class B Non-Voting Common Stock shall have one (1) vote for every ten (10) shares of Class B Non-Voting Common Stock owned by such shareholder; provided however, that there shall be no fractional votes, and no rounding of fractional votes to the nearest whole number. For example, a shareholder owning sixty-five (65) shares of Class B Non-Voting Common Stock would be entitled to six (6) votes on a matter on which the shareholders holding Class A Voting Common Stock and the shareholders holding Class B Non-Voting Common Stock, voting as a single class, are entitled to vote.
- 4. Except as Set forth in sections 1, 2, and 3 above, the Class A Voting Common Stock and the Class B Non-Voting Common Stock shall have the same terms, rights, preferences and limitations.
