

#### EXHIBIT A TO ARTICLES OF INCORPORATION FOR

#### RHODE ISLAND BUSINESS LEADERS ALLIANCE

- 4. Provisions, if any, not inconsistent with the law, which the incorporators elect to set forth in these Articles of Incorporation for the regulation of the internal affairs of the corporation are:
  - a. It is intended that the Corporation shall be entitled to exemption from federal income tax under Section 501(c)(6) of the Internal Revenue Code of 1986, as amended (the "Code"). Notwithstanding any other provision of these Articles of Incorporation or the bylaws of the Corporation, the Corporation shall not carry on any activities not permitted to be carried on by a Corporation exempt from federal income tax under Section 501(c)(6) of the Code.
  - b. No part of the net income or earnings of the Corporation shall inure to the benefit of, or be distributable to, the Corporation's members, directors, officers, or other private persons, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article 3 hereof.
  - c. To the fullest extent authorized under Section 7-6-6 of the Rhode Island General Laws, as amended, or any successor statute, the Corporation shall indemnify and hold harmless each person who shall serve at any time hereafter as a member of the Board of Directors or an officer of the Corporation from and against any and all claims and liabilities to which such person shall become subject by reason of their having been or hereafter being a member of the Board of Directors or an officer of the Corporation, or by reason of any action alleged to have been taken or omitted by them as a member of the Board of Directors or an officer of the corporation, and shall reimburse each such person for all legal and other expenses reasonably incurred by them in connection with any such claim or liability; and, if allowed by applicable law, the Corporation may advance to any such person funds to pay expenses for all legal or other expenses reasonably incurred by them in defending any such claim upon receipt of an undertaking to repay such amount, unless it is determined that such person was not entitled to indemnification hereunder; provided, however, that no such person shall be indemnified against, or reimbursed for, any expense incurred in connection with any claim or liability arising out of their gross negligence or willful misconduct or otherwise prohibited by Rhode Island law.
