The undersigned, acting as incorporator(s) of a corporation under Chapter 7-6 of the General Laws, 1956, as amended, adopt(s) the following Articles of Incorporation for such corporation:

DOWNTOWN PASCOAG ASSOCIATION ARTICLES OF INCORPORATION

WE THE UNDERSIGNED NATURAL PERSONS OF THE AGE OF EIGHTEEN [18] YEARS OR MORE, ACTING AS INCORPORATORS UNDER THE RHODE ISLAND NONPROFIT CORPORATION ACT , ADOPT THE FOLLOWING ARTICLES OF INCORPORATION.

ARTICLE I

THE NAME OF THE CORPORATION IS THE DOWNTOWN PASCOAG ASSOCIATION, AND ITS DURATION SHALL BE PERPETUAL

ARTICLE II

THE PURPOSES OF THIS CORPORATION ARE AS FOLLOWS

1. TO ENGAGE IN EDUCATION AND CHARITABLE ACTIVITIES. THIS CORPORATION IS ORGANIZED EXCLUSIVELY FOR CHARITABLE AND EDUCATIONAL PURPOSES WITHIN THE MEANING OF SECTION 501[C] [4] OF THE INTERNAL REVENUE CODE. NOTWITHSTANDING ANY OTHER PROVISIONS OF THESE ARTICLES , THIS CORPORATION SHALL NOT CARRY ON ANY ACTIVITIES NOT PERMITTED TO BE CARRIED ON BY AN ORGANIZATION EXEMPT FROM FEDERAL INCOME TAXATION UNDER SECTION 501 [C] [4] OF THE INTERNAL REVENUE CODE
2. TO ENGAGE IN ANY LAWFUL ACTIVITY FOR WHICH NONPROFIT CORPORATIONS MAY BE ORGANIZED UNDER RCW24.03.

ARTICLE III

THE INITIAL REGISTERED OFFICE OF THE CORPORATION IS THE STATE OF RHODE ISLAND, 92 PASCOAG MAIN STREET, PASCOAG, AND THE INITIAL REGISTERED AGENT FOR THE CORPORATION IS GARY TURNER

ARTICLE IV

THE MEMBERS OF THE GOVERNING BOARD SHALL BE KNOWN AS DIRECTORS . AND THE NUMBER SHALL BE FIXED BY THE BY- LAWS OF THIS CORPORATION . THE INITIAL BOARD OF DIRECTORS SHALL CONSIST OF FOUR DIRECTORS, WHOSE NAMES AND ADDRESSES ARE:

ARTICLE V

THE CORPORATION IS NOT ORGANIZED, NOR SHALL IT BE OPERATED, FOR PECUNIARY GAIN OR PROFIT, AND IT DOES NOT CONTEMPLATE THE DISTRIBUTION OF INCOME TO MEMBERS THEREOF, OR TO ANY INDIVIDUAL. THE PROPERTY, ASSETS, AND NET INCOME OF THE CORPORATION SHALL NEVER INURE TO THE OF ANY INDIVIDUAL. NO SUBSTANTIAL PART OF ACTIVITIES OF THE CORPORATION SHALL BE THE CARRYING ON OF PROPAGANDA, OR OTHERWISE ATTEMPTING TO INFLUENCE LEGISLATION. THE CORPORATION SHALL NOT PARTICIPATE OR INTERVENE IN ANY POLITICAL CAMPAIGN ON BEHALF OF ANY CANDIDATE FOR PUBLIC OFFICE.

ARTICLE VI

UPON DISSOLUTION OF THE CORPORATION, AFTER WINDING UP THE AFFAIRS OF THE CORPORATION, AND PAYING THE DEBTS AND OBLIGATIONS, THE REMAINING ASSETS SHALL BE DISTRIBUTED TO A NONPROFIT FUND, FOUNDATION, OR CORPORATION WHICH HAS ESTABLISHED ITS TAX EXEMPT STATUS UNDER SECTION 501 (C) (4) OF THE INTERNAL REVENUE CODE

ARTICLE VII

THESE ARTICLES MAY BE AMENDED AS PROVIDED BY RHODE ISLAND LAW. HOWEVER, NO AMENDMENT MAY BE MADE TO ARTICLES V AND VI.

ARTICLE VIII

NO DIRECTOR, TRUSTEE, OR ANY UNCOMPENSATED OFFICER OF THE CORPORATION SHALL BE PERSONALLY LIABLE TO THE CORPORATION OR ITS MEMBERS FOR MONETARY DAMAGES FOR CONDUCT AS A DIRECTOR, TRUSTEE, OR ANY UNCOMPENSATED OFFICER PROVIDED THAT THIS ARTICLE SHALL NOT ELIMINATE THE LIABILITY OF A DIRECTOR, TRUSTEE, OR ANY UNCOMPENSATED OFFICER FOR ANY ACT OR OMISSION OCCURRING PRIOR TO THE WHEN THIS ARTICLE BECOMES EFFECTIVE AND FOR ANY ACT OR OMISSION FOR WHICH ELIMINATION OF LIABILITY IS NOT PERMITTED UNDER THE RHODE ISLAND NONPROFIT CORPORATION ACT. ANY DIRECTOR, TRUSTEE OR UNCOMPENSATED OFFICER SHALL BE ENTITLED TO INDEMNIFICATION FOR ANY

EXPENSES OR LIABILITY INCURRED IN HIS OR HER CAPACITY AS A DIRECTOR, TRUSTEE
OR ANY OTHER UNCOMPENSATED OFFICER AS PROVIDED BY THE RHODE ISLAND
NONPROFIT CORPORATION ACT.

ARTICLE IX
